Rabbi's Message



"It's out, the air is cleared"

Thank you to 89 year-old veteran reporter, Helen Thomas. Perhaps due to dementia, she said out loud on videotape what, I suspect, many of the so-called peace activists and

members of the New Left are too smart to say out loud. Ms. Thomas said: "The Israelis should go back to where they came from and get the hell out of Palestine". Her interviewer asked her: Where should they go?" - "Oh, back to Poland, Germany, the U.S." she answered. This 89 year old pro-Palestinian syndicated columnist later apologized. But the cat was out of the bag. As of Monday, June 7th, she has resigned from her seat at the White House Press Corps.

This is truly what Israel is facing. After 62 years of independence, there are still voices calling for its destruction

Annual Meeting of Congregation House of Israel - June 13, 2010

President Millie Baron called the meeting to order at 11:03 and welcomed everyone. Twenty-two people were in attendance.

Rabbi Jerry Fox gave the D'var Torah which was the haftorah portion of the week's readings.

The minutes of the annual meeting of 2009 taken by Joanne Reagler were not read, but were approved by the board at its July 2009 meeting.

President Baron thanked the outgoing board members: Ira Kleinman, Stuart Fleischner, Ken Baim, Jerry Rephan who were not in attendance. Joanne Reagler is outgoing in her capacity as Sisterhood President.

President Baron presented the names submitted by the nominating committee to fill the vacant positions: Joanne Reagler, Alfred Lewald, and Anita Williams. Carol Kleinman will serve in her capacity as Sisterhood President. Hal Koppel moved that the slate be accepted, the second was by Gail Greenberg.

Officers of the new Temple board are the following:

Millie Baron, President David Reagler, Jr., Vice President Anita Williams, Secretary Elaine Wolken, Treasurer

Elaine Wolken gave the financial report for the period January through May 2010. We had income of \$50,519.25, an increase of 15.13 percent over the same period a year ago, but we had a net loss of \$5,066.84. The cash balance varies, and building improvements include landscaping and the memorial garden. Please see the Treasurer's report (attached) for details.

Jerry Tannenbaum asked why we keep records for the calendar year instead of the fiscal year, e.g. July 1- June 30. Elaine said that we changed a long time ago because it was simpler, but that she would send fiscal year statements to board members.

Gail asked why postage was so high. Dennis suggested that it might be related to the fund raiser. Elaine was not sure.

Hal Koppel asked about the net loss. The response was that expenses, while less than the same period a year ago, were greater than income.

Susan Siegal, Temple historian and financial advisor, gave the report on the invested assets of the Temple. As of the end of May the five funds had \$572,293.98, a 7.2 percent increase over the same period last year. We are off since October 2007, but we are back up in 2009. Brad and Elaine Wolken and Ed Berkun are the Financial Committee.

President Baron says that committee membership is being shuffled.

Ritual Committee chair is Stuart Fleischner. Gail Greenberg, Brian Trubitt, and Carole Fox are the choir for the High Holy Days.

House Committee chair is Yossi Baron. In the last year we have had the addition of the Pavillion courtesy of Jerry Tanenbaum, the cover over the back door, and new kitchen windows dedicated to the High Holy Days choir. In addition the back door and lights in the sanctuary were repaired. In addition, Mary Klompus, landscape sub chair, has contracted with Johnny Breckling to do the grounds maintenance for the front and back areas of the Temple.

David Reagler will attend ISJL and will schedule a work day before High Holy Days.

Rabbi Jerry Fox reported on his activities and those of the religious school and adult education which have all been very active. See his attached report for details of what has been done and for plan for 2011.

Membership chair has been Ira Kleinman. During his time we acquired three new families: Alfred and Jo Carol Lewald, Kate and Bill Tobakos and Drew, and Diana and Les Surfas.

<u>Carol Kleinman</u> is the chair of the Caring Committee. Please notify her about anyone in distress.

Jerry Tanenbaum is the ARZA chair.

Herman Bruckner commented that the article in the Sentinel Record about Amy Jill Levine never mentioned us. But someone else said that since the Rosenzweig Fund was the sponsor, mentioning us wasn't really important.

Joanne Reagler gave the Sisterhood report. Sisterhood has 46 paid members and 10 associate members. Ending balance is \$4330.48. These are working funds and do not include religious school and several other special funds. See attached report for details.

Sisterhood received two awards at Women of Reform Judaism International Biennial in Toronto in November: The Or Ami Award - Light of My People – and an attendance award for increase of over ten percent in membership. Holocaust Remembrance Project was presented as part of the workshop at that time. New Officers for 2010-2011 are the following: Carol Kleinman. President; Jo Carroll Lewald, Vice President; Betty Kleinman, Treasurer; and Gail Greenberg, Secretary. See the report for details.

Comments by President Millie Baron

Membership letters were sent in January: Nine members chose to increase their dues, but most did not.

Attendance – Many people are not as involved as we need for people to be.

On my mother's side, I am at least fourth generation native to Arkansas. I was born in Little Rock while my father was overseas serving in the Army. My grandmother's parents were farmers in White county when she was born in the late nineteenth century. My father retired in 1961 after serving thirty-two years active duty with the Army, and my family settled in Rogers, Arkansas, when I started junior high school. I have a B.S.E. with double majors in general science and mathematics and a minor in library science, plus M.Ed. with a major in instructional technology. Both degrees are earned from the University of Arkansas (Fayetteville). From Henderson State University, I earned a B.B.A. with a major in accounting.

Currently, I am starting my third year as high school librarian at Prescott High School, Prescott, Arkansas. This is after teaching high school algebra for several years in Prescott.

My formal education in Judaism began in the spring of 1973 and has continued today with liturgical Hebrew with Rabbi Fox. By choice, I am Jewish. My formal conversion was in the spring of 1976 at Temple B'Nai Israel in Little Rock. In the spring of 1977, I had an adult Bar Mitzvah at Temple B'Nai.

I first met Anita when I was teaching with the Little Rock Public Schools. When we first started dating and later married, I was a librarian at Hall High School in Little Rock. Anita's and my first date was a "blind date" arranged by a very good friend of Anita, and it was to a Pesach seder.

Our involvement with Congregation House of Israel began with an invitation to attend services by a fellow Lion Club member, Brian Trubbitt. Anita and I met the congregation and fell in love with its warmth and diversity. We joined the congregation when Rabbi Vicki Hollander was the Rabbi for CHI. Even though we have no children in religious school (Our only daughter lives in Brooklyn, NY), I serve on the Religious Education Board because of my commitment to education, and I see the children along with their parents as my extended family. Education is one of the 613 commandments (Deuteronomy Chapter 6). I am very thankful for CHI Sisterhood for its strong support of and to commitment to Religious School.
